Today, Sunday, March 15, 2020, the state government took further measures in the fight against COVID-19 (the corona virus). As a result, childcare is compulsory closed down from 16 March to 6 April 2020.

The government considers it important that society remains running during the COVID-19 outbreak. Some professions are necessary for this: the crucial professions. For parents or carers who work in crucial professions (or vital processes) childcare remains available (being daycare, before and after school care). The list of these crucial professions is included in the annex to this letter and can be found on the website of the state

government: <u>https://www.rijksoverheid.nl/onderwerpen/coronavirus-covid-19/cruciale-beroepsgroepen</u>.

As childcare LittlePeople, we are obliged to abide by this directive. In order to avoid unnecessary health risks and to optimally help our parents in crucial professions, only children are welcome if both parents work in a crucial profession. In addition, we will send children home if they cough/sneeze, have a fever or have a severe cold or have recently been in a risk area.

## Preschool (peuterspeelzaal)

The preschool is not a childcare centre and is therefore completely closed from 16 March to 6 April 2020. If children use the day care centre, the rules apply to day care. This means that you can go to day care as long as both parents are working in the crucial professions and the children do not cough/sneeze, have a fever or have a cold.

Specifically for COVID-19, there are crucial professions to keep society going during the COVID-19, there are crucial professions to keep society going during the COVID-19, there are crucial professions is outbreak. Parents or carers who work on this can use childcare. The list of these crucial professions is as follows:

- Care, including the production and transport of medicines and medical devices.
- Teachers and staff needed at school, such as distance learning, child care and exams.

It consists of supermarkets, the supply of supermarkets, the processing industry and the transports of this industry, but also the collection of products from farmers, the supply of, for example, animal feed and other products to farmers, the access of workers for the harvest.
